EXCLUDED OPERATIONS

- Hazmat haulers (other than fuel haulers)

- Mileage greater than 125,000 miles per truck/per year
- Drive-away operations
- Food delivery

SUBMISSION REQUIREMENTS

- Commercial Trucking Application (BPT Supplemental & ACORD's or fully completed Competitors Truck application)
- ACORD 125, 132, 194 (for filings)
- ACORD/BPT Supplemental required to bind (not quote)
- Vehicle schedule including year, make, model & full VIN
- Driver schedule including name, date of birth, state licensed, driver's license number, years' experience
- IFTA's - 4 full quarters
- Loss Runs - Current year plus prior 4 full years, currently valued (within last 60 days)

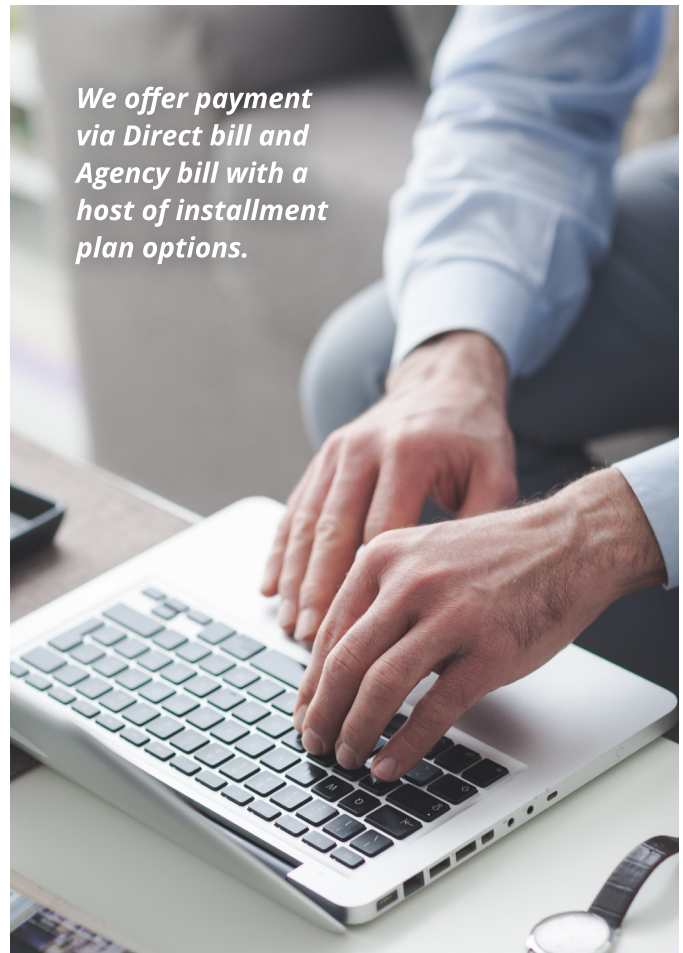
UNDERWRITING CRITERIA

MVR GUIDELINES

- 2 years experience driving similar equipment
- 23 years old minimum driver age requirement
- 3 years verifiable drivers record w/applicable CDL
- Maximum of 3 minor violations or 1 major and 1 minor within 36 months
 - **Major = speed over 20+ mph, reckless driving, DUI**
 - **Minor = speed 5-19mph over, equipment violations**

SAFETY REQUIREMENTS

- Strong internal safety program
- Good driver hiring program
- Satisfactory Risk Management report after binding
