Frequently asked questions

Does Nirvana change my rate based on my safety performance?

Your rate is locked-in during your policy and won't change in the event of an accident or claim. Leveraging our safety tools will not affect your monthly payments, rather it gives you the opportunity to monitor safety over time and improve your standing for renewal.

Does Nirvana have access to my dashcams?

Some fleets may be required to connect their in-cab cameras, however, Nirvana does not monitor drivers in their vehicles or proactively pull camera footage unless there is a claim.

Does Nirvana automatically submit claims generated from my telematics collision data?

No. Reporting a claim is always the responsibility of the fleet and Nirvana will never submit claims on your behalf, even if there are crash alerts on your devices.

Does Nirvana store and share my telematics data?

Your data is securely stored using industry-standard security practices, featuring state-of-the-art encryption to safeguard your information. Access to this data is limited to your fleet, designated insurance agency, and individuals you choose to share the data with through our Safety Intelligence Platform (or when required by law). We never sell or trade data for any purpose.
